Walk with Christ Banner Competition

6 September 2019

Primary school aged students are invited to create and carry a banner (**Entry**) at the Catholic Archdiocese of Sydney (**CAS**) Walk with Christ procession on Sunday 24 November 2019 from 2:30pm to 4:30pm (**Competition**). Entries will be judged in 2 age groups and the Entry judged to be the best out of each age group will win the Prize (see details below).

Walk with Christ is the annual Eucharistic Procession through the streets of Sydney on the Feast of Christ the King organised by CAS. Thousands of people took part of last year's joyful public proclamation and act of worship to invoke Christ's blessing upon our beautiful city.

Prize

Entries in the Competition will be judged in 2 separate age groups as follows:

- Kindergarten to Year 2; and
- Year 3 to 6.

There will be 1 winner from each age group (2 winners in total). The winner from each age group will win the following prize (**Prize**):

- \$100 gift card from the Smiggle® shop. The gift card is subject to Smiggle's terms and conditions available at https://giftcards.smiggle.com.au/CMS/Page/giftcardterms; and
- 1 family pass for 2 adults and up to 3 children to the VIP area for the opening night of the Lights of Christmas at St Mary's Cathedral Forecourt.

Winning Entries will be notified by email and through their school by 27 November 2019.

Most Reverend Bishop Richard Umbers will attend the school of each winner to present the Prize. Photographs of the winners, along with their winning Entries, will be featured in *The Catholic Weekly* in both print and digital format.

Eligibility

The Competition is open to all primary school aged students from Kindergarten to year 6 who attend a school (or a registered home school) within the geographic boundaries of CAS (**Entrant**).

To enter into the Competition, the Entrant's parent/guardian must:

- submit by email at <u>cheryl.fernandez@syd.catholic.edu.au</u> by 2:30pm on 24 November
 2019 (ie. before the start of the procession):
 - o a completed Competition Application Form;
 - a signed Conditions of Entry;
- ensure that the Entrant participate and carry their banner at the Walk with Christ procession on 24 November 2019 and present it at a designated area at the St Mary's Cathedral Forecourt where the Entrant will be photographed with their banners; and
- accompany and supervise the Entrant during the Walk with Christ procession.

At the end of the procession, each Entrant will receive a Walk with Christ wristband.

Each Entrant may only submit one Entry in the Competition.

Conditions of Entry

- 1. Information on how to enter and about the prize (**Prize**) forms part of these Conditions of Entry (**Conditions**). By entering the Competition, each Entrant agrees to comply with, and be bound by, these Conditions.

- 3. Participation in the Competition is open to primary school aged students from Kindergarten to year 6 who attend a school within the geographic boundaries of CAS. Officials, employees and volunteers of CAS, along with their immediate families, are ineligible to enter.
- 4. The Competition commences on **11 September 2019** and closes at **2:30pm on 24 November 2019**.
- 5. Incomplete or illegible Entries, or any Entries that do not comply with these Conditions, will be deemed invalid.
- 6. Each Entrant's parent/guardian must ensure that the Entrant complies with these Conditions.
- 7. Entries will be judged on Monday 25 November 2019 by a panel of judges (**Judges**) from CAS comprised of: Anita Quigley (Director of Communications & News Media); Peter Rodrigues (Creative Team Leader); and Cheryl Fernandez (Leader of Learning: Youth Ministry SCS).
- 8. CAS acknowledges that the Entrant owns all intellectual property rights in his or her Entry. The Entrant's parent/guardian warrants to CAS that the Entry submitted is the Entrant's work and does not infringe the intellectual property rights (including without limitation copyright and moral rights) of any third party.
- 9. This is a competition involving skill and talent. Chance plays no part in determining the winner. Each Entry will be individually judged according to its originality and creativity.
- 10. Failure of an Entrant to comply and adhere to these Conditions may result in that Entry being deemed invalid.

- 12. The parent/guardian of each Winner consents to CAS filming and photographing the Winner and agrees to execute a document giving consent in the form **attached**.
- 13. All costs associated with the Prize (including accommodation, meals, entertainment and ancillary costs) are the responsibility of the Entrant's parent/guardian.
- 14. The Prize is not transferable or exchangeable and cannot be taken as cash.
- 15. In the event that for any reason the Winner does not take an element of the Prize then that element of the Prize will be forfeited.
- 16. The Judges' decision is final in any matter relating to or arising out of the conduct of this Competition and no correspondence will be entered into.
- 17. CAS is not responsible for:
 - (a) costs incurred by an Entrant in any way associated with this Competition;
 - (b) any incorrect, inaccurate or incomplete information communicated in the course of or in connection with this Competition;
 - (c) any technical malfunction of any telephone network, computer on-line systems, servers or providers or internet failures.
- 18. If for any reason this Competition is not capable of running as planned in any respect due to any cause beyond the reasonable control of CAS, CAS reserves the right in its sole discretion to cancel, postpone or amend the Competition.
- 19. CAS will not be liable for any loss in connection with this Competition or accepting or using any Prize, except any liability which cannot be excluded by law (in which case liability is limited to the minimum allowable by law).
- 20. The parent/guardian of each Entrant:
 - (a) agrees that the Entrant will carry their Entry and participate in the Walk with Christ procession on Sunday 24 November 2019;
 - (b) will accompany and supervise the Entrant during the Walk with Christ procession;
 - (c) consents to CAS filming and/or photographing the Entrant with his/her Entry and having the Entrant's name recorded for the purpose of enabling the Judges to decide on the Winners of the Competition and for the film and photograph be used by CAS for publicity and marketing of the Competition and in connection with the Walk with Christ procession; and
 - (d) acknowledges that he/she will not receive any compensation in relation to any publicity and CAS will determine, in its absolute discretion, the content, format and style of any material to appear in such publications.
- 21. CAS may require any Entrant to provide proof of attendance at a primary school (or a registered home school) within the geographic boundaries of CAS. Identification considered suitable for verification is at CAS' discretion.
- 22. CAS is bound by the Australian Privacy Principles and the *Privacy Act 1998* (Cth).
