Where the Safeguarding Complaint relates to allegations of **historical child abuse**, the Safeguarding Office will manage the Safeguarding Complaint including any necessary reports.

Where the Safeguarding Complaint relates to **contemporaneous harm or abuse** (such as new allegations of Reportable Crime, Reportable Conduct or Risks of Significant Harm), all necessary steps should be taken immediately in relation to the safety of a Child/Children or Adult at Risk at issue (including calling 000 in an emergency) and otherwise the appropriate state authorities should be notified as soon as possible. These include NSW Police, the NSW Office of the Children's Guardian and the Department of Communities and Justice. The Safeguarding Office will assist by notifying the relevant state authorities or assisting mandatory reporters to make notifications.
