



Called & Gifted Discernment Process 2024

The Called & Gifted Discernment Process (**Process**) is an apostolate of the Catherine of Siena Institute based in Colorado. The Process will be delivered virtually in Australia in collaboration with the Catholic Archdiocese of Sydney (**Archdiocese**) and will consist of workshops, a one-on-one gifts interview with each participant, and a further session known as "Discernment in Depth". Participants will have access to the Called & Gifted Learning Platform for six months and will receive a print and e-book Complete Resource Manual.

The Archdiocese is the organiser of the Process in Australia.

The Process will take place virtually over 8 sessions, with a one-hour interview, from Monday 29 April to Monday 15 July 2024. Each participant must have his or her own unique email address.

Participants must be aged 18 years or above, and priority will be given to those from Archdiocesan parishes.

In order to participate in the Process, participants must complete the online registration and agree to the Terms and Conditions set out below.

Called & Gifted Discernment Process Terms and Conditions

Registration and cancellation

1. Registration for the Process is essential and will close **12 April 2024**.
2. Registration for the Course is through the TryBooking ticketing platform at: <https://www.trybooking.com/COSZV>.
3. The registration fee for the Process is \$140.00.
4. An additional \$4.00 is payable per registration which covers booking and administration fees of the TryBooking ticketing platform (**TryBooking Fee**). All prices are inclusive of GST.
5. Payment of the total registration fee is required at the time of registration. Registration is non-refundable.
6. If for any reason, the Process cannot commence or continue as planned in any respect, the Archdiocese reserves the right to cancel the Process or change the date of the Process at its discretion.
7. Due to limited numbers, acceptance of a participant is within the sole discretion of the Archdiocese.
8. If the Archdiocese cancels the Process under clause 6, participants will be entitled to a refund of the total registration fee paid for the cancelled Process, less the TryBooking Fee.

Filming and photographing

9. I am 18 years of age or above.
10. I may be filmed and/or photographed (**Footage**) when attending the Process.
11. I agree to and permit the Archdiocese and its nominees using the Footage and my name, image, likeness and voice in accordance with this consent.
12. I consent to the Archdiocese and its nominees, without limitation, using, reproducing, exhibiting, editing, adapting, compiling with other works or materials, transmitting, broadcasting, publishing and distributing the Footage in any media at its discretion, for educational, promotional, marketing and other purposes (including commercial purposes)

associated with the Process, or the Archdiocese's events, or consistent with the Archdiocese's (and broader Catholic community's) activities and objectives.

13. I acknowledge that the Archdiocese is not obliged to publish or otherwise use the Footage or any part of it.
14. I agree that any form of intellectual property rights in the Footage and all works derived or created under it are owned by the Trustees of the Roman Catholic Church for the Archdiocese of Sydney on behalf of the Archdiocese, and any intellectual property rights that I may have in the Footage are fully assigned to the Trustees of the Roman Catholic Church for the Archdiocese of Sydney on behalf of the Archdiocese.
15. To the full extent permitted by law, I consent to the doing of anything in relation to the Footage that (but for the consents provided in this Terms and Conditions document) would otherwise infringe any moral rights or similar non-assignable personal rights that I might otherwise have including but not limited to publishing the Footage without attribution and modifying/ adapting the Footage.

Privacy

16. I acknowledge that the Archdiocese and its nominees collect my personal information for purposes of organising the Process and contacting me about activities and initiatives of the Archdiocese or where I have otherwise opted in to receiving communication. The Archdiocese may disclose my personal information to its related entities, contractors and third-party service providers for purposes relating to the Process including to organisers of the Process for purposes of providing the Process to me.
